EARLY LGBT+ HISTORY IN JAPAN

EDO PERIOD

- Shintoism, tolerance towards people of all sexualities
- Same-sex practices
 - Shudo, wakashudo, and nanshoku
- No taboo or stigma associated with male-male sexual

MEIJI & TAISHŌ PERIOD

- Seiyoku in novels and writings
 Borrow from western countries *"Hentai* boom"
 - Queer seiyoku
 - Female-female interest

LGBT+ HISTORY DURING & AFTER WWII

Japan's ideology pre and postwar times

 Heterosexuality and pronatal

 Homosocial, mostly Japanese men

 Military brotherhood

- "Love between comrades" (sen' yūai)
- Postwar, traditional sex and gender ideology were loosened up
 - "curiosity seeking" (*ryōki*)
 Early 1970's Japan and onwards:
 - LGBT+ activism
 - Rise in lesbian (rezubian) identity
 - First ever pride parade

- Discrimination
 - Homofobia, transfobia, etc
 - National-level recognition
 - Legal issues
- Something as simple as coming out can be a struggle in Japan

COMING OUT IN JAPAN



Japan has relatively few openly-queer individuals:

- Discrimination
- Lack of legal protection COMING OUT TO PARENTS
 - Abusive responses
- Nothing changes (negative) **REASONS NOT TO COME OUT**
 - Heteronormativity
 - Age gap
 - Fear
 - Family issues

DISCRIMINATION

ALL FORMS OF DISCRIMINATION:

- Hate speech & Bullying
 - Heightened risk of suicide
- • Homophobia
 - Housing & Financial Benefits discrimination
 - National-level Recognition
 - 🔸 🜼 Marriage equality
 - Transphobia
 - Gender reassignment surgery issues +
 - + Physical & Verbal violence
 - Ignored or excluded
